Garbage Collection & Policy

Garbage Collection Day is Tuesday all year

Yard Debris Collection Day is Monday from May 1 to October 31

The collection days may change without notice due to stat holidays.

Policy

1. Each household must provide enough containers for

their needs.

- 2. All garbage is to be bagged. Loose garbage will not be picked up. The property owner is responsible for picking up and properly bagging loose garbage
- 4. Garbage bags are to weigh no more than 50 pounds.
- 5. Garbage must be placed

as near the road as possible but placed so it does not impede traffic.

6. Yard debris includes hedge, shrub, grass clippings and leaves. Yard debris must be bagged in biodegradable/compostable bags or it will not be picked up. Bags can weigh no more than 50 pounds. Small tree limbs are to be bundled in 3 ft lengths.

- Concrete
- Tires

As we approach the 2010 summer season I would like to welcome the following new employees, Firstly, I would like to welcome Caralen Okolita as the administrator. Caralen joined us in June of 2009. In October of 2009, Kim Sastaunik joined the Resort Village as the Bylaw Officer. In March of this year, Peter and Lynn Gigian resigned as the maintenance employees. We will surely miss them after 23 years of service to the Resort Village. I would like to wish them success in their future endeavours. I would like to welcome Heath Walton as the maintenance supervisor and Dennis Leader as the maintenance assistant. I trust that you will be welcoming and patient to our new employees and direct any concerns or complaints to the office. We would also like to welcome back Kyle and Berke McClintock as our summer workers.

Discussions on a new lagoon proceeded over the winter months. The partnership has given a proposal to Sas-kWater for continued use of their lagoon and is awaiting the receipt of a formal agreement from SaskWater.

Your Council has been busy with various projects over the winter. You have already received a survey in conjunction with the development of our community plan and revision to our zoning bylaw. Council has also been working on a solution to the drainage issue on beach lane and the paving of beach lane, parking issues at the boat launch, home occupations, adequate and efficient snow removal, negotiations with the R.M. of North Qu'Appelle over the proposed subdivision in the R.M., use of road allowances as storage areas by residents, new signs for the entrances to B-Say-Tah and the boat launch area, passing of new bylaws and policy and procedures.

North Valley Waste Management Authority Inc. has mandated the use of "BIODEGRADABLE" bags for the disposal of lawn, leaf and garden refuse. Your Council supports this initiative to enable the efficient composting of this type of material and to extend the life of the landfill pit. Please see the regulations on garbage and other refuse disposal in this newsletter.

Council is pleased to report that there will be swimming lessons again this year. Please see the notice in this newsletter.

Who Can Run?

He or she must fit the following criteria:

1. I am the full age of 18 years or will be on election day:

- 2. I am a Canadian citizen and I have resided in Sas-katchewan for at least six months.
- 3. I am not disqualified by The Local Government Election Act or any other Act holding the office for which I am a candidate;
- 4. If elected, I will accept the office for which I was nominated;
- 5. l:
- (a) I have resided for at least three consecutive months immediately preceding the

date on which this nomination paper is submitted in the resort village or on land now situated in the resort village; (b) have been the owner for at least three consecutive months immediately preceding the dated on which this nomination paper is submitted of assessable land situated in the resort village of land now situated in the resort village;

(c) have been the lessee for at least three consecutive months immediately preceding the date on which this nomination paper is submitted of assessable land situated in the resort village of land now situated in the resort village; of assessable land situated in the resort village of land now situated in the resort village; (d) am the spouse of a person mentioned in clause (a), (b) or (c).

The candidate's nomination papers must be signed by at least five electors of the municipality.

Who Can Vote?

To be eligible to vote you must fit the following criteria:

- 1. I am a Canadian citizen.
- 2. I am the full age of 18 years or will be on election day.
- 3. I have not already voted at this election
- 4. On the day of election, l: (complete one)
- (a) have resided for a least three consecutive months immediately preceding the day of the election in the Resort Village of B-Say-Tah or on land now in that resort village;
- (b) have been the owner for at least three consecutive months immediately preceding the date of the election of assessable land situated in the Resort Village of B-Say-Tah or of land now situated in that resort village;
- (c) have been the lessee for at least three consecutive months immediately preceding the date of the election of land situated in the Resort Village of B-Say-Tah or of land now situated in that resort village; or
- (d) am the spouse of a person described in clause (a),(b) or (c)

It doesn't matter how you vote, the important thing is that you vote!

Due to the resignation of Peter and Lynne Gigian the Village has found it necessary to hire two new employees as well as our usual summer students. Both summer students have worked for the Village in previous years. The Village has also purchased a new half ton truck and trailer for use by maintenance staff.

Currently we are trying to

determine the requirements for drainage along Beach Lane between Highway 210 and the boat launch. The drainage problem needs to be resolved prior to paving the lane. A consultant has been hired to correct the many drainage issues in the Village.

As the North Valley Waste Management Authority will not allow lawn clippings and garden waste to be placed in the pit, all such waste will be required to be placed in biodegradable bags. The Village will not pick up this waste unless it is in the required bio-degradable bags. However, individuals may take these wastes to the landfill in other containers provided they are emptied in

the appropriate location and the containers disposed of properly. The landfill staff will advise you of the procedures.

With everyone's cooperation I am sure that we can maintain the Village to the degree we have in the past.

Nuisance Bylaw



B-Say-Tah Point

Cottage owners are encouraged to keep their properties and adjacent property tidy and free of "undesirable". We all know how quickly things can pile up, which is why the Bylaw Enforcement Officer is asking that owners take a look around their property and voluntarily abide by the Nuisance Abatement Bylaw.

This bylaw is intended to

provide for the abatement of nuisances that include property, activities or thing that adversely affect:

- the safety, health or welfare of people in the neighbourhood;
- people's use and enjoyment of their property; and
- the amenity of a neighbourhood.

A nuisance can include a building in a ruinous or di-

lapidated state or repair; and unoccupied building that is damaged and is in imminent danger to public safety; land that is overgrown with grass and weeds; untidy and unsightly property; junked vehicles; vehicles that do not have a valid license plate; are rusted, wrecked, dismantled, inoperative or abandoned; and open excavations on property.

Zoning & Building Bylaws

Resort Village bylaws requires that a Development/Building permit must be submitted for approval before any construction, demolition or removal of a building begins

The developer may be required to submit one or all of the following along with the Development/
Building permit application:

- Two sets of plans and

specifications of the proposed building.

- A current real property report prepared by a registered land surveyor.
- A current topographical report with or without land elevations may be required.

The Development/Building Inspector will evaluate the compliance of the construction, or demolition to the related Acts and Bylaws.

Inspections will be done on site before, during and at the finish of construction, demolition or the moving of any structure.

Permits are not required for fences **under** six feet in height or for laying paving stones.

Copies of the Building Bylaw and Zoning Bylaw are available at the Resort Village office.

Saskatchewan Environment & Resource Management (SERM) requires a permit application to be completed before any work near a lake and stream shore area can take place.

Common activities that can affect fish and fish

habitat are: lake shore alteration during cottage construction; depositing sand for beach development; removing sand, gravel and/or rocks from lake and stream shore areas, diverting or damming streams; dredging or draining marsh lands; installing road culverts;

removal of trees and shrubs; and the erection of retaining walls.
